## **OFFICE ORDERS**

These office orders are issued to strengthen the monitoring of the performance of the MPHW (M) and MPHS (M) in the State of Punjab

- 1. The ACR (Annual Confidential Report) of the MPHW-M and MPHS-M will be recorded by the District Epidemiologist (designated as District Programme Officer NVBDCP & IDSP) at first which will be submitted to the SMO of the block concerned and ACR will come to Civil Surgeon of the district concerned for final acceptance.
- 2. The districts should abstain from putting the duties of MPHW-M and MPHS-M in branches other than surveillance. If the districts have to put the MPHW-M and MPHS-M on some other duty, the concerned MPHW-M and MPHS-M should report to the duty (from where pay is claimed) for at least 2 days a week.
- 3. The districts should report to the State, whenever MPHW-M and MPHS-M is put on some duty other than surveillance.
- 4. If MPHW-M and MPHS-M is posted for full time in duty other than the assigned duties, the concerned MPHW-M and MPHS-M will not be eligible for FTA (Field Tour Allowance).

The orders have been issued to strengthen the surveillance in the State keeping in view the targets of Malaria Elimination and to take remedial measures in case of outbreaks of various diseases. These orders will come in force with immediate effect.
