Whereas the Governor of Punjab is satisfied that the State of Punjab is threatened with the outbreak of Dengue and that the ordinary provisions of law for the time being in force are insufficient for the purpose. Now, therefore, the Governor of Punjab is pleased to make the following additional regulations and instruct the heads of all health institutions and other medical and paramedical staff of Government as well as Private Hospitals and Laboratories in the State of Punjab regarding the capping of rate of the ELISA based tests for diagnosis of Dengue accordingly:-

"Private sector hospitals and laboratories should not charge more than Rs 600/- per test for confirmation of Dengue".

This is in continuation of the earlier notification issued by the Govt. vide No. 16/46/1986-3HB4/727128/1 dated 05/04/2016 and in context of the Government of India, National Vector Borne Disease Control Programme, (Directorate General of Health Services), Ministry of Health and Family Welfare, Delhi D.O.No. 7-119/2013/NVBDCP/DEN/Review Meeting-P dated July 2016. The above said regulations and instructions shall come into force at once and shall remain valid till further orders.
