Subject: Guidelines regarding SSH (Sentinel Surveillance Hospitals) for Dengue and

Reference subject mentioned above, the following guidelines are issued for the SSHs (Sentinel Surveillance Hospitals) for Dengue and Chikungunya:

- 1. Two days per week i.e. Tuesday and Friday are fixed for testing of Dengue im order to avaoid wastage of the kits. However, in case of clustering of the suspected cases or an outbreak like situation, the days of testing can be increased by the SSH in consultation with the Civil Surgeon of the District concerned.
- 2. The microbiologist recruited under IDSP shall be given the charge of the SSH for Dengue and Chikungunya (where ever available). Regular Microbiologist/ Pathologist shall work where such post is not available.
- 3. SSH incharge in consultation with the Senior Medical Officer and Civil Surgeon is allowed to outsource one Lab Technician/ Assistant for aperiod not exceeding six months in a year. (Preferably from July to December) at their own level. The budget for this activity has to be booked under the funds for SSH under NVBDCP.
- 4. The procurement of the consumables, repair and maintenance of the equipment and infrastructure of the laboratory has to be done at the level of the Prof. and Head Microbiology in the Medical Colleges and Senior Medical Officers in Civil Hospitals in consultation with the Microbiologist incharge of the SSH as per the guidelines of Govt. of India (attached for reference). The budget for this activity has to be booked under the funds for SSH under NVBDCP.

- 5. Civil Surgeons are directed to transfer the funds of SSH to the concerned SSH immediately for smooth functioning of the laboratories, so, that the recruitment of Lab Technicians and procurement of consumables is done at the level of SSH.
- 6. All districts to send the name, contact number and email id of the SSH incharge designated by email to the State headquarter at punjabnvbdcp@gmail.com immediately.
